On March 15, SMAers and their guests will take a docent- narrated bus tour of the United States Military Academy at West Point (see insert in this newsletter). Stopover points will be:

The West Point Museum– The oldest and most diversified military museum in the U.S. Four floors of large weapons, ancient to modern firearms, artifacts, and uniforms of historical figures and gallery displays of the history of warfare of the US Army and of American Wars.

The Main Cadet Chapel—Constructed in native granite and dedicated in 1910; its stained glass windows were executed by the Willet Studios in Philadelphia.

The Trophy Point—A scenic overlook of the Hudson River valley and location of the granite column Battle Monument and artillery pieces captured in many battles.

Also included is lunch at the Thayer Hotel, newly renovated and one of the "Historic Hotels of America".

Our next trip will be on April 10 to Hartford. We will visit the Wadsworth Atheneum air museum and tour the Governor's Residence with lunch at Vito's by the Park.
