Wednesday, March 11, 2015

Tara Contractor, the Bruce Museum's Kress Interpretive Fellow, will present highlights of the current exhibition, "Northern Baroque Splendor: The Hohenbuchau Collection from Liechtenstein." There are 64 paintings covering the Golden Age of Dutch and Flemish art between the late 16th and early18th centuries illustrating everyday life of that time. It is the largest art show ever at the Bruce Museum. The paintings are arranged chronologically and exhibit beautiful and alluring still-life pictures of fruits, intricate goblets and detailed tapestries. Also on display are landscapes of rural scenes, turbulent seas and tranquil rivers. In addition, portraits of an assortment of characters and emotions are shown. Well-known artists such as Gerard Dou and Peter Paul Rubens are included. Ms. Contractor is a graduate of Scripps College and the University of London Courtauld Institute of Art. She worked directly with the museum's director in organizing this outstanding exhibit.
