Virtual Online Tax Preparation for Connecticut's At-Risk Population



DMA member **Pat Gentile** will talk to us about his work helping less-privileged families and individuals to cope with and manage the tax-preparation process. Pat is presently the Executive Director of Virtual VITA, Inc. (VITA stands for Volunteer Income Tax Assistance.) He works directly in partnership with the IRS to assist low-income, at-risk families and elderly households with free tax preparation, tax counseling and advocacy. His group is the first within the State to receive IRS approval to provide clients with virtual online tax preparation utilizing a client's cell phone. His team is the Lead Coalition Partner of the nationally approved virtual tax preparation

program called "Get Your Refund," and is responsible for training other VITA Partners throughout CT and Rhode Island. Locally, he and his 60+ retired professional colleagues provide pro bono tax preparation throughout the inner cities and towns in Fairfield County serving over 8,000+ clients each year.

Pat is a retired CPA with over 30 years of experience in business and spent the majority of his career rising through the ranks of American Banknote Corporation, one of the world's largest providers of secure transaction systems and solutions. He retired in 2014 as the CFO and COO of global operations to spend some quiet time with his wife Terry.

The US Navy Rail Gun



Captain Dave Adams, USN (ret.), is uniquely qualified to speak on the subject of naval rail guns. Captain Adams was class of 1990 at the University of Texas, Austin, and graduated with a BS in Mechanical Engineering, followed by postgraduate work leading to a masters, with distinction, in strategic planning. In turn, this led to his becoming speechwriter for the Chief of Naval Operations – probably safer than his next tour in Afghanistan, where he commanded the

Joint/Interagency Provincial Reconstruction Team. He returned to take command of SSN-763, USS Santa Fe, followed by command of SSGN USS Georgia, a ‘boomer.’ He became Deputy Editor-in-Chief of the Naval Institute’s journal, “Proceedings,” where he made his reputation as a serious long-range geostrategic thinker as well as a critic of some of the Navy’s procedures and plans for future war-fighting.

Dave is currently Director -- Navy Museums, Naval History and Heritage Command. He is responsible for the Navy’s Ten Museums, Historic Ships and Aircraft Maintenance

Sailing Around the World: The Voyage of Bebinka



Six weeks after **Scott Kuhner** met Kitty in the late 1960s, he proposed, and four months later they were married. She was up for adventure, so they took their honeymoon on a 22 ft sailboat with a Porta Potty and sailed her from Westport to Martha's Vineyard and back. Scott talked Kitty into buying a 30ft Allied Seawind Ketch, and two years later in 1971, they quit their jobs and spent 4 years sailing around the world. Scott was a securities analyst for EF Hutton and his boss could not believe he was going to leave his well-paying job.

They returned to Rowayton, bought a house and started a family.

When their two sons were 9 and 11, Scott and Kitty decided to show them there is more to the world than just Connecticut. They bought a Valiant 40, named her Tamure, took the boys out of school and spent another four years sailing around the world. Six years later, a family reunion lit the spark for her 2017 debut novel, *We were the Lucky Ones*. It took Hunter nearly a decade to begin the saga of her grandfather and his four Kurc siblings whose descendants span the globe. After creating a color-coded timeline to keep track of the many family branches, she turned to researching archives and museums and contacting ministries and magistrates. As she tells it, she "plotted an outline and chapter summaries and from there began the terrifying task of putting my story to paper!"

Georgia was born in Massachusetts and raised in Providence, Rhode Island. In 2000, she received her bachelor's degree in psychology from the University of Virginia and settled on a career in marketing and branding. After seven years in Seattle, Washington, Georgia and her husband headed back east. Currently, she freelances as a copywriter for adventure travel outfitters, including Austin Adventures and The Explorer's Passage. Georgia Hunter now lives in Rowayton with her husband and young son.

The Opioid Epidemic worsens during the Pandemic: An Update

John Hamilton will speak on the field of addiction treatment and prevention. He is nationally recognized as an expert in this field. He brings three decades of experience to his role as president and CEO of Liberation Programs and also chairs the Advisory



Board for the Connecticut Department of Mental Health and Addiction Services and serves on the Governor’s Alcohol and Drug Policy Council. Previously, John was chief clinical outreach officer at Mountainside Treatment Center, a nationally acclaimed drug rehabilitation center with locations in New York and Connecticut. He served as CIO of Recovery Network of Programs, a nonprofit behavioral health agency serving the Greater Bridgeport Community. John is past chair of the Dissemination Committee for the National Institute for Drug Abuse Clinical Trials Network, past chair of the Community Treatment Providers

Caucus, past president of the Southwest Connecticut Mental Health Board, past president of the New England Association of Drug Court Professionals and co-founder of the Greenwich Father’s Forum. In 2013, John was a recipient of the American Association for the Treatment of Opioid Dependence Nyswander-Dole Award for his contributions to the field of addiction treatment. He last spoke to us in April 2019.

David Hurwitt, 82, passed away November 19. He is survived by his wife of fifty-seven years, Susan, their four children – Douglas, Laura Towle, David, and Sarah Clark, their spouses, and 11 grandchildren.

David graduated from Harvard University in 1960 and received an MBA from Harvard Business School in 1964, following a stint in the Air Force. He spent twenty-six years with General Foods Corp, including six years in Europe running the company's English and French subsidiaries before returning to the US as General Manager of the Breakfast Foods Division, and then Corporate VP of Marketing. David subsequently worked as VP of Marketing for Flagstar, owner of Denny's, and Hardee's largest franchisee.

David then began nearly 20 years as a dedicated mentor and coach to a variety of small businesses.

David volunteered regularly for many organizations, including The Rotary Club of New Canaan, served on the boards of The Institute for Global Ethics, Shakespeare on the Sound in Rowayton, ABC (A Better Chance) in Darien, and spent 10 years as Board Chair for Creative Connections of Norwalk. He was a lifelong learner, athlete, and artist who loved to connect with people. When you spoke to him, he was endlessly curious and thoroughly engaged. An avid photographer and traveler, his favorite subjects were always people.

An avid golfer and tennis player, David more recently turned his enthusiasm for sport to playing pickleball with DMA colleagues, enjoying time with them the very morning of his passing, and winning his last four games.



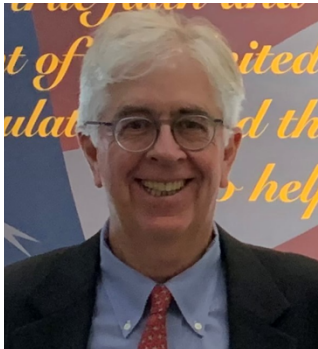
Tom Glover, 90, who for years did a caricature of each DMA president for this newsletter, died peacefully on December 17 in Exeter, New Hampshire. Tom was a caricaturist with a unique ability to capture the essence of those he drew, and he touched thousands of people with his cheerful perception

He was born in New York and raised in Great Neck, Long Island. The course of Tom's life took a decisive turn when he headed north to St. Lawrence University, where he honed his drawing skills at a local watering hole called the Tick Tock, where his caricatures hung. He graduated in 1952, and after serving in the army Tom

returned each year to draw new SLU students. A blind date was arranged with one of the new coeds, and Tom's fate was sealed.

Tom and his wife Diane went on to make a wonderful life based in Rowayton and were married for 62 years. From an ever-busy home studio Tom built a thriving business. A private service was conducted at Christ Church in Exeter on December 27, with a Committal service to follow during warmer weather in Rowayton.

Book Discussion Group



Harris Hester reports that in November a group of 18 met via Zoom and discussed Isabel Wilkerson's *Caste: The Origins of Our Discontents*. The book is somewhat controversial in that it compares current U.S. race relations to Hitler's Nazi Germany and the status of the Dalits in India. Nevertheless, we had an interesting discussion and most of the group enjoyed this thoughtful book.

In December the group discussed *A Long Petal of the Sea* by Isabel Allende. This is a novel that might be considered historical fiction. It was the story of two refugees from the Spanish Civil War who crossed the Atlantic to Chile and experienced a half century of political and personal upheavals concurrent with real historical events in Europe and South America. On **January 13**, the group will discuss Daniel Yergin's book, *The New Map: Energy, Climate, and the Clash of Nations*. The book covers many topics well but there is a section on the recent history of the Middle East that is especially well done and informative.

On **February 10**, the book is *Agent Sonya* by Ben Macintyre. This is our second book by this author. Earlier in the year we read and enjoyed *The Spy and the Traitor* also by Ben Macintyre.

Hiking



On December 11, **Dave McCollum** and **Bob Plunkett** led a near record 22 DMA members, spouses and friends on a wonderful hour and 45-minute tour of the perimeter of Sherwood Island. The weather was magnificent as was the opportunity for hikers to see and talk to each other (even through masks) rather than on Zoom. The easy terrain

and wide paths made conversation possible and the group took advantage of it by taking nearly two hours to walk three miles!

Sherwood Island, the oldest state park in Connecticut, covers 234 acres. A beautiful feature of the park is the Connecticut 9/11 Memorial sited on a point with a direct view towards New York City. The names of all Connecticut residents who died from that attack are memorialized on stones embedded on the monument.

It was a thoroughly enjoyable morning and a great way for DMA members to get together outside during this pandemic. Dave and Bob will explore further walks over the winter.

Current Affairs



Bob Baker reports that the Current Affairs group had well-attended and lively Zoom discussions. On November 19, **Harris Hester** led a discussion on the results and implications of the presidential election. Harris correctly predicted that the recounts were unlikely to change the outcome, but he also outlined the likely lawsuits and recount rules that indeed did delay resolution. Harris also led a discussion of Biden's priorities as president, including the pandemic stimulus initiatives, tax changes, student debt forgiveness, lowering of Medicare eligibility to 60, climate change (difficult), foreign policy and many other areas. Still to come, the results of the Georgia Senate elections which could be crucial to Biden's ability to get proposals through Congress. On December 17, **Joe Spain** led a discussion on "Urban Violence and the Rule of Law." Joe reviewed well-publicized incidents involving minorities going back to Watts in 1965 up through 2020 incidents in Minneapolis, Portland, Ore., and Kenosha, Wis., among others. On one side, many minority citizens view these incidents as beginning with minor offenses and ending in violence because the person arrested was black. On the other hand, many are concerned that police are holding back enforcement of the law because they are at risk if they don't do everything precisely right. The group agreed that the small number of bad cops need to be disciplined or removed, that defunding the police was not the answer, but that additional funds should be allocated to better train police especially in de-escalating situations. 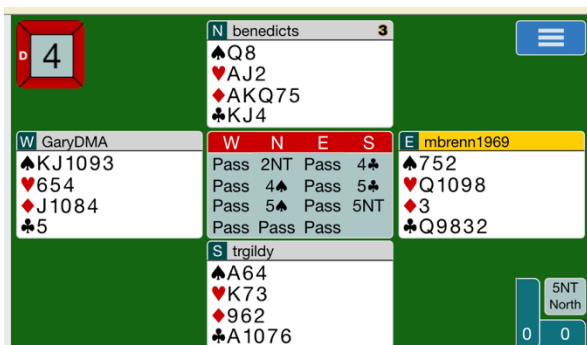
Investment Discussion Group



Jim Phillips notes that the Investment Discussion Group has had very high attendance in its Zoom sessions over the past two months. One benefit of Covid has been the ease with which DMA members can join in the discussion, Jim says, but more importantly participants are impressed with the quality of discussion. The group benefits not only from contributions of those who have made a career in professional money management, but also from the industry and technical expertise found among participants. **Chip Schroeder**, for example, discussed the potential of hydrogen as a fuel for ships and railways and the companies likely to benefit from hydrogen energy adoption. The last two sessions of IDG discussions focused on "recovery plays" and companies with strong "secular tailwinds". More recently, an informal group is sharing ideas between meetings. Lately, the IDG informal group has focused on renewables and possible cybersecurity investments.

The group meets on Zoom on the first Monday of each month at 10 a.m. The meetings feature presentations on stocks of potential interest and participants engage in a lively discussion on the outlook for both markets and individual investment opportunities. In advance of scheduled meetings, Jim encourages IDG members to suggest companies to him, and background information can be circulated for pre-discussion reading.
