
Wednesday, November 6, 2019

Wednesday, November 13, 2019




Nestor T. Carbonell will deliver a talk based upon his forthcoming book, *Why Cuba Matters: New Threats in America's Backyard*. Even after the US restored diplomatic relations with Cuba in 2015 and removed it from the list of states sponsors of terrorism, he notes, the Castro regime intensified repression on the island and bolstered the besieged Maduro dictatorship in Venezuela with intelligence and paramilitary forces. Russia and China have steadily penetrated Latin America while Washington has looked elsewhere.

Mr. Carbonell was born and raised in Havana. He went into exile from Cuba in 1960 and subsequently participated

in the Bay of Pigs invasion. Mr. Carbonell earned a Doctor of Law degree from the University of Villanueva in Havana, and holds a Master of Law degree and a Strategic Marketing Certificate from Harvard University. He joined PepsiCo in 1967 as Counsel, Latin America, and progressed through a variety of management positions. He retired from PepsiCo in 2008 as Corporate Vice President in charge of International Government Relations and Public Affairs. Mr. Carbonell is a member of the Council on Foreign Relations and the Board of Overseers of the International Rescue Committee. *Arranged by John Hess*

Wednesday, November 20, 2019



Wes Haynes, Executive Director of the Merritt Parkway Conservancy, will talk about the "Merritt Parkway's History and its Future as a National Treasure." He will speak about the origin, construction, and impact of this historic road that changed the design of American roads and life in Fairfield County. He will also discuss the challenges it faces and what needs to be done to ensure its future as a safe and beautiful drive. Mr. Haynes has a long career in historic preservation including senior staff positions with the Connecticut Trust for Historic Preservation, New York Landmarks Conservancy, Preservation

League of New York State, and New Jersey Historic Trust. He has worked on restorations of Central Park, the New York State Capitol in Albany, the Adirondack Great Camps, and directed a survey of 1,500 historic mills for the Connecticut Trust.

Dr. Sarah Kahn, M.D., will speak about "The Interaction of the Gut and the Brain." We each have 100 trillion bacteria which are living and working in our gut. These microscopic critters, collectively known as the microbiome, help our body to digest food, process nutrients, make vitamins B and K, and produce immune molecules that fight inflammation and heal wounds. Dr. Kahn notes that the most impressive role of this busy workforce may be, surprisingly, in the brain. Dr. Kahn is a well-known and highly respected gastroenterologist at Stamford, Hospital. She received her medical degree from Geisel School of Medicine at Dartmouth and has been in practice for more than 20 years.





Investment Discussion Group



Jim Phillips reports that the Investment Discussion Group invites its members to suggest stocks which they own personally, but want a second opinion from the group. Other stocks for discussion reflect changing industry dynamics or trends. In September, the group discussed four stocks: CoreSite Realty (COR), a data center REIT with assets that support e-commerce clients in eight major markets; Thermo Fisher Scientific (TMO), a high-quality play on biotech; PayPal (PYPL), a leader in the digital wallet

space; and **GE** as a value stock play. In October, the group noted that the strong US dollar has generated massive capital inflows to the US equity and bond markets, and the economy is dominated by consumer and government spending, not trade or manufacturing. Stocks discussed included companies with noteworthy insider buying: Kraft Heinz (**KHC**), Ulta Beauty (**ULTA**), Lyondell Basell Industries (**LYB**), Kinder Morgan (**KMI**), Abbvie (**ABBV**), SunRun (**RUN**) and Hannon Armstrong (**HASI**). The group meets at 9 am the first Monday of every month at 30 Old Kings Hwy South, 1st floor.

Money Matters

Doug Campbell reports that the Money Matters Group had interesting, well-attended discussions on topics that can affect DMA members' wealth and wealth planning. In **September** the topic was wealth transfer to children, grandchildren, and others. Tax efficient wealth transfers include the gift of \$15,000 per recipient per year (\$30,000 if both spouses gift). Other methods include help with purchase of a house, either through a loan or by setting up an LLC. College age recipients can be helped with student loans, or by directly paying for college or student health care. Another tax efficient technique is setting up a 529 for benefit of grandchildren before they reach college age. The discussion covered assistance with other major events, such as helping a younger family member establish a new business. In **October** the speaker was successful money manager **John DeSantis** from Civic Financial in Rhode Island, who presented his Annual Report of Trivia and Investable Trends, a lighthearted look at facts that could presage investment opportunities. Money Matters meets the 3rd Wednesday of every month from 8:45 am to 9:45 am in the Lillian Gade room (before the regular DMA meeting).

Copps Island Oyster Tour





Bryan Hooper reports that in late October a party of nine DMA members were treated to a tour of the oyster beds off Norwalk, hosted by the firm of Norm Bloom & Son, who for three generations have been farming and harvesting oysters marketed as Copps Island Oysters. Tour guide was **Don Bell**, the firm's environmental health director. **Norm Bloom** (son of the founder) spent time educating the group about the oyster business, aided by the firm's staff members Jimmy Bloom, Dick Harris, Rachel Precious, and Mike the Lobsterman. The group was taken out on an oyster boat to see oyster beds and

watched oysters raised to the deck of the boat, hosed, and returned to the Sound as part of the process of checking the state of specific oyster beds. The trip featured lectures on the health of the Sound, and an explanation of oyster, lobster, and clam life cycles. At the end of the tour the group watched oysters being sorted for the market.
