# Virtual VITA – Background on Volunteer Income Tax Assistance Program in CT



## THE VOLUNTEER INCOME TAX ASSISTANCE PROGRAM IS THE SINGLE MOST CRITICAL ANTI-POVERTY TOOL IN CONNECTICUT

#### **Tax Credits & Refunds**

- Earned Income (up to \$6,000 per family)
- Child Care (up to \$2,000 per child)
- Educational (up to \$2,500 per student)
- CT State Earned Income (up to \$1,200)

#### **Economic Impact Payments (stimulus)**

- \$1,200 per individual
- \$500 per qualifying child
- Part of the CARES ACT Initiative

# Elimination of professional tax return preparation fees

- \$300 per return
- Providing unbanked and underbanked with free bank accounts

#### Self – Employed Pandemic Unemployment Assistance

• \$15,000-\$20,000 in benefits for qualified self-employed individuals (CARES ACT)

## THE EARNED INCOME CREDIT (EITC) THE ANCHOR IN THE FIGHT AGAINST POVERTY IN CONNECTICUT



### THE EARNED INCOME CREDIT AND CHILD TAX CREDIT POVERTY UPLIFT NATIONWIDE

#### Earned Income Tax Credit and Child Tax Credit Have Powerful Anti-Poverty Impact

Millions of people lifted out of poverty or made less poor by EITC and Child Tax Credit, 2018



During the 2017 tax year, the average EITC was \$3,191 for a family with children (boosting wages by about \$266 a month).



## HOW THE VOLUNTEER INCOME TAX ASSISTANCE PROGRAM HISTORICALLY DELIVERED ITS CRITICAL MISSION IN CT

- Over **700 IRS Trained Certified Volunteer Preparers** throughout CT provide free income tax preparation.
- Close to 60 CT brick and mortar sites
- Annually prepare over 18,000 returns and deliver \$28 million in refunds to our Target population.
- We save our community close to \$6 million in tax preparation fees. A TRUE GRASSROOTS EFFORT!



# **COVID-19 CHALLENGES IN CT - WHAT WE KNEW\***



- Over 7,500 of 18,000 clients needed to file when brick & mortar closed on March 19<sup>th</sup>.
- Anxiety and fear drove the balance of our client base underground.
- Unclaimed refunds of close to \$200 million among 80K+ households.
- 90,000 of severely impoverished families needed to file to receive their Stimulus.


# What Virtual VITA Did To Meet the Challenge

Direct outreach to unserved 2018 VITA families and individuals to offer them a simple to use "virtual" and secure app to complete their 2019 tax returns w/o COVID-19 risk

#### Mobilization Activities delivered within 4 weeks


- Developed Secure Encrpyted Portal
- IRS approval of all applications & methods within one week of testing.
- Trained & Consolidated 58 sites into 10 Virtual sites with over 200 Volunteers preparing returns Safely from home.
- Hired a project manager and team of marketing specialists for state-wide outreach.
- Developed the online tools to contact and track our client interactions.
- Developed peer-2-peer marketing campaigns to engage clients and build trust.




